1. About Us -

Cod Nerc is a non-profit organization working with the people since 2005 in many parts of the districts in Mizoram. Basically working at grass root level and reaching the horizontal reality of the community. It gives values to experience gained by the community; each and every intervention it delivers are explore from the community. It has a strong & vibrant team work with proper governance system, promptness in responsibility. It also focuses on the development of the community through uplifting and empowerment while maintaining equality and justice. The organization has been organizing various skill development trainings among both rural and urban youths who lack access to information and communication method. They also work on public health and educating women on rights and possible skill development in collaboration with various implementing partners. Cod Nerc is committed to strengthening culture and identifying steps to skill building even more inclusive work environment. The name implies the characteristic of its versatility to response to the dynamic human needs, driven by contextual need face by a community/society, prioritizes the emergent needs of the people and trying to contribute towards the achievement of the Sustainable Development Goal (SDG). It delivers services in consultation with the people, gives emphasis on people led intervention and gives importance to sustainable development.

Introduction: Similar to the previous year, vulnerability due to pandemic circumstance particularly the Corona Virus Disease 2019 (COVID-19) continued for months that worsen the situation of every lives threatening to ultra poor families who are living in a low standard both in urban and rural areas. Moreover, situation is tremendously difficult for the poor especially family having older people & physically challenged persons. Ultra poor families could not get enough supply of basic meal/food for their survival. However, by the end of the reporting year ie, 2021, the situation improved somehow so the organization therefore focuses more on providing assistance among the people in terms of introducing livelihood opportunities and entrepreneurship. Also, distributing food basket and utensils such as cooking materials in the refugee camp, essential commodities and providing livelihood opportunities to the targeted displaced people from Myanmar. As a matter of fact, in this reporting period, majority of the project activities were carried out in a way of providing materialistic assistance in the project

About projects and programs-

Health Intervention

1. Two **TIs (Targeted Intervention) ie,** Injecting Drug User (IDU), Female Sex Worker (FSW) are being implemented since 2008 focusing people living with HIV/AIDS, Injecting Drug User (IDU), Female Sex Worker (FSW) aiming to eradicate the numerous uses of drugs and its relating problems. We continue to work on reducing the hazardous spread of HIV/AIDS in Thenzawl, Serchhip district and Khawzawl in Khawzawl district. As on April 2021 Thenzawl DIC, registered clients includes 225 IDU Clients, 51 FSW and 54 IDU dispensing for OST, who are all in the age group of 19 - 44. While in Khawzawl district, the area Cover are: DIC Vengthar Khawzawl, Sub-DIC Zuchhip, Khawzawl and Sub-DIC Kawlkulh. Altogether there are 533 IDU (including 2 newly HIV case detected) who are in the age group of 17- 45 in which 126 clients are dispensing for Opioid Substitution Therapy (OST).

Service Provide & Work Done by both the TIs (Thenzawl & Khawzawl):

- Since pandemic, services to clients such as Health Camp, numbers of Community Events (carrom chinese checker, Ludo, playing card etc) conducted indoors. Similarly, required prescibe medicines by expert are being delivered to clients residences.
- Advocacy meeting is held in different places with different community leaders on needle/ syringe exchange programme and on OST.
- Community Clean up is done every months of the year except during total lockdown.
- Clients meeting, strengthening outreach for service providing to clients were counducted various times at hotspot and DIC level.
- In-house training which is held at DIC conference hall on mapping of population size estimation.
- Mapping 32 areas in and around the town of Thenzawl which is done by the staff, in this mapping the main aim is to find out how many High Risk groups are there in the area.

- Coordination metting are held at DIC level every week.
- Create new syringe dispense center where the client freely exchange their syringe through drug dealer.

In both the DICs, their main activities include; Condom distribution, IPT (treatment) ART initiation, General medical checks-up, Health Camp & Community Event (including FSW) Needle/Syringe Exchange program, assisting financially to the needy, Organizing HIV and Drug Awareness among Students, KTP Members, Community Leaders etc. This intervention has aware the youth and general population and greatly prevented the rate of transmitting HIV/AIDS in the intervention area and society as a whole.

2. Orphan and Vulnerable (OVC)


Orphan and Vulnerable Children (OVC) project was implemented in collaboration with YRG CARE under NACO through USAID as one component of Project ACCELERATE since April 2019 in Aizawl district. The main aim of Project ACCELERATE is to provide technical assistance and to develop novel models and strategies for the fight to stop the epidemic of HIV/AIDS. The OVC programme looks after Children Living with HIV (CLHIV) i.e below 18 years of age. As there are limited policies and guidance on care and support of CLHIV, based on the learning from the programme, it is aimed to develop SOPs and Guidelines for care and support of CLHIV. As the agreement between India and the funding agency i.e PEPFAR does not allow the programme to provide direct service delivery, OVC utilizes those programmes and schemes already provided under the aegis of Government of India. The OVC programme is carried out on rights-based approach without violating the rights of children. It is also carried out on a need basis of the targeted children and their family that is linkages with Government services are done as per the needs and requirements of the beneficiaries.

Livelihood & Social Entrepreneurship-(through Skill building)

1. Nabfins Loan-

a) Current scenario of Nabfins implementation –Nabfins Limited is an initiative of NABARD born out of serious concern about the practices of NBFC MFIs in which they provide loan as Group called SHG and JLG. It was implemented in Mizoram in 2016 so was by Cod Nerc as Business and Development Correspondent (B&DC) with Nabfins Limited signed the agreement since then.

b) Process of Sensitization and Mobilisation -

In order to provide loan to any member or group, Cod Nerc maintain strict guidelines in which they study and verify the applicants before making decision of disbursing loans. Moreover, all the require documents are collected and make sure they do not have ongoing loan repayment before availing loan from Nabfins through Cod Nerc. The necessary processes to follow in order to avail loan are: member must form a group consisting of 4-7 members per group only female which are not related or one person per Household, every group member must have personal bank account. After all these criteria are fullfiled, Cod Nerc, being B&DC of Nabfins Limited verify and recommend it for sponsor and again Nabfins staffs and Cod Nerc conducted group grading. Only if they have gone through the various verification, loan are disburse to group member's own bank account in a very less interest amount. Infact, the loanees from vulnerable community does not have problem in repayment.

d) Due to the Global outbreak of Corona Virus, any economic activities that was suspended for a while had effected loan repayment. It affects Nabfins business also in different ways either loan disbursement and loan collection was simultanously decrease. Loan disbursement to new group was halted since August 2021, no loans has been granted out, currently we are monitoring on Loan repayment collection. Also, the organisation act as a guarantor for all groups and provide door steps services so that nobody face problems in accessing the loan or in repayment. Cod Nerc even helped collect loan by visiting every household every month and remind them their due date for repayment beforehand.

e) Current existing group -

At present, we monitor 265 groups consisting of 1066 group members (Live Loan account) altogether from 65 villages from Aizawl and Serchhip District in the state.

2. Bridge IT Mature Phase-

Bridge IT Project was implemented in the state since April 2018 in partnership with Development Focus, Bangalore. The 1st phase was completed in March 2020 so now the 3rd phase of the project is still going on in which their main activities includes –Xerox, Printing, Passport Size photo making and printing, laminating of documents, making of ID cards etc. The activities were deeply hampered by the COVID-19 Pandemic. There was a decrease in demand by customers and also the shipping of goods for the activities was also delayed due to unavailability of intra-state transportation.

Amidst all the hurdles, the entrepreneurs try their utmost to generate income by opening online shopping business through WhatsApp, facebook and in every possibility. Also, some entrepreneurs started servicing of television and computers for the community at a reasonable cost. The entrepreneurs were doing their best to meet their needs and generation income. In the meantime, DF introduced the business of Mini ATM through Roinet Company in January 2022. Trainings were conducted among the 6 entrepreneurs in which 4 out of 6 are now doing the business in their respective villages.

3. Project "Deen Dayal Upadhyaya Grameen Kaushalya Yojana" (DDUGKY)

This project is under the Ministry of Rural Development (MoRD) and is part of National Rural livelihood Mission (NRLM) having task with the dual objectives of adding diversity to the incomes of rural poor families and cater to the career aspirations of rural youth. The project focused on skill building of rural youth between the ages of 15 to 35 years from poor families. As a part of the Skill India campaign, it plays an instrumental role in supporting the social and economic programs of the government like the Make In India, Digital India, Smart Cities and Start-Up India, Stand-Up India campaigns. On the 14th January 2022, Cod Nerc signed MoU with Mizoram State Rural Livelihood Mission (MzSRLM) to this project targeting to train on "Domestic data entry Operator" among 300 youth within 3 years covering all districts in the state. In this trade, all trainees have to complete 960 hours of training under the guidance of a reliable trainers. The project envisage placement to the certified trainees after completion of the required training.

In this DDUGKY project, the residential preparation is going on like collection of equipments for trainees' accommodation and required learning materials so on and so forth. Training of 1st batch consisting of 90 candidates will soon be carried out within this year.





4. Integrated Tribal Development Fund (TDF):

This project is implemented after signing of MoU with NABARD at Darlawn R.D Block in three villages; Sakawrdai, Zohmun and Tinghmun which is the exterior part of Aizawl district. First sanction installment was disbursed on the 13th October 2021. The Project targets 200 tribal farmers with an emphasis on promotion of sustainable livelihood activities, 160 farmers for orchard farming and 40 farmers for piggery development. The 160 orchard farmers are divided in two batches 1st & 2nd Batch i.e. 80 farmers per Batch, 40 farmers from Sakawrdai, 30 farmers from Zohmun and 10 farmers from Tinghmun. Initially, Litchi and papaya will be cultivated as the main crop and king chili as the intercrop plant. At the same time, pig rearing will be included for other livelihood activities.

<u>Description of Components</u>: Horticulture, soil conservation and water resource development

- a) Water Resource Development For Orchard Farmers: Construction of Dug out pond for rain water harvesting is introduced in the project area as most crops are rainfed. The capacity of the proposed pond is 12000 lts. Pond liner which is 24 X 18 ft size, 150 GSM is distributed among the 80 orchard farmers. All the 80 orchard farmers have completed the construction of dug out pond. For this water connection 200 meters (15mm) irrigation pipe is distributed among the 80 orchard farmers on the 19th April 2022 and irrigation pipe was on 1st March 2022.
- b) Soil Conservation and Land Management: To conserve soil and protect the orchard land half moon terracing is proposed to minimize surface runoffs of nutrient soil and recharge deeper soil strata during the dry season. Soil management involves raising of cover crop after removing the weeds. For our intervention, king chilli is introduced in the project area and pit digging is also proposed for litchi and papaya. To all the 3 batches or within the whole 3 years, vermi compost will be provided to each farmer twice a year from 1st year till 3rd year and slake lime once a year.
- c) Horticulture Development: 80 litchi saplings, 85 red lady papaya saplings and 300 king chilli saplings each will be given to the 1st Batch farmers. A total number of 80 litchi saplings was given to each farmers on the 23rd April 2022 and papaya and king chilli will be given out during the fourth week of June to July.

5. SOLAR MAMA (Solar engineer):

Solar Mama Project is implemented in collaboration with Barefoot College International (BCI), Rajasthan since November 2021. This project aims on promoting sustainable development with a focus on rural communities, by providing solar powered equipment ie, home lighting system. 5 months training of the 3 selected mamas from Sakawrdai, Zohmun, Tinghmun undergone training at BCI campus in Tilonia, Ajmer district Rajasthan. A total of 150 households are covered under this project, 50 households per village. In the post training, the 3 solar mamas/engineers support their respective communities in solar electrification and maintenance.

For a smooth functioning of the project, village Energy Environment Committee (VEEC) is established in which a joint bank account will be open and managed by the committee members. Initially, the beneficiary has agreed to pay a monthly contribution of Rs 170 per HH in which 60% of the total contribution will be solar mama's monthly salary i.e. Rs 5100, the remaining 40% of the monthly contribution will be for the purpose of replacing the batteries after 5 years and maintenance of the Home Lightning System, change batteries and repair of equipments.. This contribution will be collected monthly by the VEEC and will be deposited to the bank (VEEC Account).

6. Farmers producers Organisation (FPO)

Cod Nerc has been engaged towards the promotion of Farmers welfare & development to promote sustainability for which it has been forming FPOs in rural areas from an implementing NABARD support fund. As of now, it has three FPO viz, Samlukhai PFO under Aibawk Block, Khanpui FPOs under Darlawn RD Block and Sesawng FPO under Thingsul RD Blocks Prior to that, it has successfully promoted two FPOs in Thenzawl under Serchhhip RD Block and at Sesawng under Tingsul RD block during 2016 to 2019.

FPO is a joint venture & entity where farmers are coming together to strengthen their joint effort to focus on improving farming, backyard gardening through collectivisation by contributing share from its member. There are basically two types of FPOs like FPO that deals with farming and the FPO focusing on Animal Husbandry. Cod Nerc provides hand holding support like Training & mobilisation of members, Board of Directors training, Business Development Plan, Chief Executive Officers Training, Linking with banks & other supportive agencies. The FPOs are collecting share and they are presently engaged in promoting business in their area of operation.



7. Off Farmers producers Organisation (OFPO)

OFPO has been implemented since 2013. However, due to market fluctuation; decline in profit and market stagnation. Cod Nerc with the help of NABARD launched Ramlai Handloom Producers Organization (RHPO) in January 2018 consisting of 800 shareholders in the OFPO with total Share Capital contribution is up to Rs 16 lakhs. Product Diversification Centre cum Training Centre has been set up in which weavers were mobilized to have better cooperation to stand up against market intermediaries and OFPO have run business from the start-up capital of share collected among members. Every year, RHPO members are sent to participate in mela and exhibition multiple times. From product diversification centre/ value addition centre, different kinds of products like bags of different kinds, waist coat, shirt, skirt etc. are design from handloom product. Till date, more than 50 youths have been trained from the centre. Skill Development Training programme helps the weavers to improve the quality of product which leads to rise in price. Entrepreneurship training helps the weavers to access E-Marketing and sent their product to USA, Australia, UK etc. Due to the project positive impact among the weavers the total number of weavers is increased to 1700 from 800 by 2022.

WELFARE INTERVENTION

1. "Integrated Right base Approach"

The organization also focuses on empowering the most vulnerable groups in the society covering 12 villages in Serchhip district & 3 villages in Aizawl district through "Integrated Right based Approach". Active step were taken up towards helping the people through CBOs and local NGOs. In this reporting period, 6 SHGs was formed and provide training on Book Keeping, Accounting, credit linkage etc also attended Financial Literacy Camp conducted by State Bank of India in collaboration with Cod Nerc. Initially, Mushroom Cultivation Technique was introduced in 3 of the project villages while the beneficiaries are selected by CBOs in their respective villages. Through this training, large numbers of villagers received the technique and its correct procedure of cultivation.

Training on Medicinal Plant was conducted on the 29th November 2021 at Vantawng Group YMA Run, Thenzawl. The program is mainly on introduction training cum demonstration on value added product on medicinal plant (Aamla and Broken Bones Trees). The training was conducted in collaboration with Cod Nerc and College of Horticulture - constituent of Central Agricultural University, Selesih, Mizoram, in which 10 members from target families attended.

In the meantime, in connection to COVID 19, dry ration was distributed to 10 families in which items includes such as Rice, Dal, Potato, nutrela etc. Vaccination Camp was conducted in Kanan Village in consultation with CBO and MO through which a total of 345 individuals got vaccinated (male-161, female – 184), providing travel support of pre and post vaccination to 19 people from the marginalized family. For livelihood support 10 chicks per family was also provided to them covering 13 families, In extending the services, 4 COVID Community Care Centre (CCCC) in Thenzawl was also covered by providing medical equipment; sanitary napkins, Glove, Garbage Bag, hand sanitizers, vitamin C, Sanitary pads, hand wash etc are distributed. During September 2021 medical equiptments like fongter pulse oximeter, infrared thermometer, Digital BP Apparatus are distributed to – Kanan, Vengthar and Sialsuk Villages.

2. <u>Project Activities on Project-"How Are You"?</u>

Since 2019, Project-How Are You was implemented in 21 different localities in Aizawl city under the guidance and linkages with the Local authority such as MHIP (Mizo Hmeichhe Insuihkhawm Pawl), MUP (Mizoram Upa Pawl) and most importantly the YMA (Young Mizo Association). From the very beginning of the project inception, regular services provide includes; Home visit, educational support, Microfinance support, Skill development training etc.

The following are the new services provided under the Project:

- a) Access to Public benefits: The HAY Team takes initiative for the HAY Families in order to access public assistance benefits and services. The Mizo Students Union along with other independent donors has planned to contribute an enormous amount of smart phones as donations for the poor in Mizoram. The HAY Team made this initiative accessible from it, receiving 2 used smart phones for the HAY Families that has helped the children attending online classes with ease from home.
- **b) Sutpui Facilitation Centre:** HAY Team has approached different departments and organizations in order to access government schemes and security for the HAY families.
- c) **Distribution of Biscuits in aid of COVID 19:** Cod Nerc received large amount of biscuits donated by *ITC Company* and was equally distributed among the HAY families and Local Level Task Force (LLTF) in many localities. Also is was distributed in three districts of the organization intervention area.
- d) **Crisis fund:** Under crisis fund, financial support for house rent, for buying essential commodities, medical purpose, etc, are given to the families as well as individuals who are unable to continue their job as well as unable to earn for their living due to health issues or lack of job opportunity.
- **e) Organizing one day workshop:** The HAY Team organized one day workshop on leadership and design for social transformation by inviting HAY families to attend which

was guided by a renowned speaker Mr. Sudarsan Rodriguez. Moreover, Mr. PL. Liandinga, well known well known and influential person for the Mizo people gave a momentous speech about his mode of living and how he established his goals that are quite benefits for the participants.

Need based Intervention

This particular program does not have a specific time period. It usually is carried out according to need based and its availability to apply from Small Industries Development Bank of India (Sidbi) regular and CSR projects that are applicable to our focus areas. In fact, baking training was also conducted in Collaboration with SIDBI covering 12 project villages in which 60 trainees undergone the training. Through this training, it positively impacted on the people helping them generating more income; 33 trainees have used baking as part time income source and 11 people as full time income source. Similarly, financial literacy camp was conducted in collaboration with SBI in the same town-Thenzawl and Serchhip in district Serchhip. In the meantime, in connection to COVID 19, dry ration was distributed in collaboration with Project "Flashlight21" among 30 BPL families who are deeply affected by Covid-19 in Serchhip Town.

In connection to livelihood, poultry project are being carried out dividing into 3 phases consisting of 25 people in each batches in Sesawng Aizawl district and Khawzawl, Khawzawl district supported by NABARD. All these beneficiaries were first given training on poultry farming by vety doctor. On then, chicks were given in free to people among the disadvantage people who are less fortunate in the locality are now starting to get the profits after the grown chicken are being sold or reproduced more chicks. 2nd phase distribution of chicks was done on September 2021 which is followed by 3rd phase on ie, March 2022.

Additionally, NABARD supported rural Haat (rural market place) construction in Sesawing and Thenzawl completed and being utilizes by the communities. This rural Haat has helped the villagers in selling their agricultural products in bulk in their own villages that that they no longer need to travel to cities for such business.

In the early 2021, the unfortunate displaced people from Myanmar settle in camp arranged and provided by the YMA different parts of Mizoram. Since February 2022, Cod Nerc also agreed to help out 500 hundred families for 6 consecutive months which is supported by Impulse NGO Network (INGON) Shillong. The cover villages or camps includes; Zokhawthar, Mualkawi, Zote,

Khuangleng, Sesih, Lianpui, Leisenzo, Khawbung and Khuangthing which are all under Champhai District -. The assistance is carried out by supplying dry ration consisting of rice, dal, potato, soyachunks, cooking oil It also includes onetime distribution ie, Basic utensils for 150 families, Sanitary pads for 150 women and nutrition (cerelac) for 150 children. The join NGOs built a good rapport with the local NGOs and concern authority or government department as crop plantation are also being introduced in order to address the food scarcity among displaced people as well as the host community. In this plantation, short term crop plantation consists of French bean, soyabean, Potato, Off season cabbage and maize/corn covering 375 families and 150 hectares (375 acres) is under process. Similarly in long term, crop plantation includes; Low Chilling Apple, covering 150 families and 150 hectares. The main aim of intervention is to fight for hunger while preventing human trafficking. The policy makers opines that if the displace people have food security and can earn some income it will eventually lead to prevention of human trafficking.


